The Homeowner has read and understands the applicable provisions of the Declaration of Covenants, Condition and Restrictions for the Fairview Meadows Property Owners Association concerning design, modification and construction. The Homeowner shall be responsible for complying with all other Codes and Ordinances and obtaining necessary permits and approval to conduct work prior to commencing work.

All completed applications must be submitted via the App Folio Online Portal. If you are not set up on the portal, please feel free to reach out to me so I can help get you set up.

Homeowners must include the following with the Home Improvement Application as applicable. All submissions must be clear, concise and understandable enough for the ARC to make an informed decision.

## Storage Buildings

$\square$ Marked survey or plot plan where improvement is desired.
$\square$ Contractor proposal that includes picture or elevation drawings, materials and measurements.
$\square$ Colors and shingles must match home.
$\square$ Maximum size is 1200 square feet, minimum eight ( $8^{\prime}$ ) foot height and not exceed sixteen ( $16^{\prime}$ ) feet height and located behind the front building line of a residence.
$\square$ Placed on a poured-in-place reinforced concrete slab.
$\square$ No corrugated galvanized metal will be allowed.

## Arbors/ Pergolas/Patio Extensions/Additions/Playscapes/Concrete Extensions

$\square$ Plot plan is required. Location of addition must be clearly marked on plot plan.
$\square$ Dimensions, list of materials, color samples, elevation drawings, and square footage must be provided.
$\square$ Submit color of stone \& concrete overlays. Samples or pictures must be provided.

## Landscape/Landscape Edging/Trees

$\square$ Location of landscape plans must be marked on survey/plot plan.
$\square$ Plants/Trees/Species need to be listed, spacing between plants and sizes of plants/trees.
$\square$ Landscape edging sample pictures required.

## Swimming Pools/Spas

$\square$ Location of swimming pool/spa must be marked on survey/plot plan.
$\square$ Dimensions, lists of materials, elevation drawings and square footage. Include distance from property lines.
$\square$ Swimming pools must be surrounded by wrought iron style fencing with a minimum height of four (4) feet in the event the backyard is not fenced.
$\square$ Above ground pools are specifically prohibited.

## Solar Vents/Solar Panels

$\square$ Dimensions, picture, product details, number and location of vents or panels must be provided.

## Exterior Paint

$\square$ Paint samples are required. Submitting two color choices is suggested.

## Roof Replacement

$\square$ Contractor's proposal that shows manufacturer's warranty (30 year/lifetime required), color, and brand of shingle ( 3 -tab shingles are not permitted).

## Fences

$\square$ Plot plan is required. Location of fence must be clearly marked/highlighted on plot plan.
$\square$ Contractor's proposal that shows materials used, top cap, border, stain/paint, and height of fence.
$\square$ Stain/paint sample.
Please note: Incomplete submissions will not be accepted for review and will be returned.
