No house trailer, mobile home, camper, boat trailer, or similar wheeled vehicle shall be used i) as a permanent Residence or ii) be stored or parked on any Lot except in a closed garage or within the fenced, wall or enclosed portion of such lot and any fence, wall or other enclosure shall be subject to approval by the Architectural Control Committee.
